

Horse Racing Rulings and Reconsiderations (January to December 2007)

Investigations of suspected violations of horse racing rules and policies and the provisions of the Gaming Control Act and Regulation may result in penalties that are communicated in a Judge's Ruling (Standardbred racing) or in a Steward's Ruling (Thoroughbred racing). These violations can be appealed to the Director, Racing Division, for reconsideration.
